### Notice Regarding the Repurchase of the Company's Shares

(Under the Provision of its Articles of Incorporation pursuant to Article 165, Paragraph 2 of the Companies Act of Japan)

The Dai-ichi Life Holdings, Inc. (the "Company"; President: Seiji Inagaki) hereby announces that its board of directors has resolved at its meeting held on May 15, 2018 to repurchase the Company's shares under the provision of Article 156 of the Companies Act of Japan, as applied pursuant to Article 165, Paragraph 3 of the same, as follows.

#### 1. Reason for the Repurchase of the Company's shares

To enhance shareholder return through the implementation of a flexible capital policy and the improvement of capital efficiency.

## 2. Details of the Repurchase

(1) Class of shares to be repurchased: Shares of common stock

(2) Aggregate number of shares to be repurchased: Up to 39,000,000 shares (3.33% of the total issued

and outstanding shares excluding treasury stock)

(3) Aggregate price of shares to be repurchased: Up to 39.0 billion yen

(4) Period of repurchase of shares: From May 16, 2018 to March 31, 2019

(5) Method of repurchase of shares: Open-market repurchase by the trust method
