(1) Reasons for the revision

The Company projects that its consolidated ordinary revenues for the fiscal year ending March 31, 2019 will exceed its previous forecast because it expects an increase in premium and other income of The Dai-ichi Frontier Life Insurance Co., Ltd. due mainly to favorable insurance product sales. The Company’s forecast for its consolidated ordinary profit and net income attributable to shareholders of parent company for the fiscal year ending March 31, 2019 remains unchanged.

(2) Shareholder dividend forecast

The Company’s dividend forecast for the fiscal year ending March 31, 2019 (53 yen per share) remains unchanged.
