Dai-ichi Life Holdings Announces Change of Organizational Restructuring and Officers Effective on October 1, 2025

Dai-ichi Life Holdings, Inc. (the "Company"; President: Tetsuya Kikuta) hereby announces the change of organizational restructuring and officers effective on October 1, 2025.

As an asset owner, our group of life insurance companies manages a wide range of assets investing premiums entrusted to us by our customers. We aim to achieve both medium- to long-term stable investment returns and the resolution of social issues. In this context, our group has set the goals of becoming a globally top-tier insurance group and leading the future of the Japanese insurance industry by FY2030. To achieve stable capital efficiency that consistently exceeds capital costs and to provide attractive products that meet the diverse needs of our customers, we believe it is necessary to further strengthen our investment management capabilities.

Based on the above, we will consolidate the investment execution functions related to investments and loans that are commonly conducted by The Dai-ichi Life Insurance Company, Limited ("Dai-ichi Life"; President: Toshiaki Sumino) and The Dai-ichi Frontier Life Insurance Co., Ltd. ("Dai-ichi Frontier Life"; President: Mamoru Akashi). Specifically, we will establish a new organization within the Company that consolidates the investment execution functions in the areas of fixed income investment, alternative investment, and structured finance, as well as a related function to these investments and loans from both companies. We will undertake these operations from both companies and carry out integrated and efficient investment execution for the group. *

Our group will continue to aim for further improvement of the group's overall investment management capabilities by maximizing the use of group resources, starting with this consolidation of the investment execution functions.

Organizational Restructuring

To centralize and consolidate the investment execution functions in the areas of fixed income investment, alternative investment, structured finance conducted by Dai-ichi Life and Dai-ichi Frontier Life, along with credit function related to these investments and financing activities, we establish the following new units.

- Fixed Income Investment Unit
- Alternative Investment Unit
- Corporate and Structured Finance Unit
- Credit Unit
